GST on flavoured milk: Madras HC decision relies on SC ruling in Mohit Mineral case



In a significant ruling, the Madras High Court, responding to a petition by Parle Agro challenging flavoured milk's classification, drew on a Supreme Court precedent, asserting that GST Council recommendations aren't binding on the Union and states. Applying the principle of noscitur a sociis, the court specified that 'Beverage containing milk' refers exclusively to plant or seed-based milk, not dairy milk.

While classifying flavoured milk under GST tariff heading 0404, the court emphasized the need for a fresh government notification to amend the tax rate. Experts anticipate an appeal to the Supreme Court, recognizing the decision's importance for taxpayers in disputes. PwC India noted the judgment's significance in challenging tax demands based on GST Council discussions.

highlighted However, it the government's authority to implement decisions through legal such amendments. Raghavan Ramabadran of Lakshmikumaran & Sridharan welcomed the court's Attorneys clarification, calling it a refreshing decision for the dairy industry, emphasizing the need for thorough analysis before adjusting tax positions.

Gov Reports Robust Growth in MGNREGA and Crop Insurance; Addresses LSD in Livestock



In a recent parliamentary update on December 5, 2023, Giriraj Singh, Union Minister of Rural Development, shared that the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) has generated a substantial 2,216 million persondays this year, indicating a notable increase from the previous fiscal year.

Narendra Singh Tomar, Union Minister of Agriculture, highlighted a significant surge in farmers' applications under the Pradhan Mantri Fasal Bima Yojana, growing by 33.4% and 41% year-on-year for 2022-23 and 2021-22, respectively. The Kharif 2023 season also witnessed a remarkable 28.9% growth in farmer applications and a 24% increase in insured area.

Additionally, Parshottam Rupala, Union Minister for Fisheries, Animal Husbandry, and Dairying, addressed the concern of Lumpy Skin Disease in livestock, reporting a total of 73,390 cases in 2023, with 16,302 currently active cases. The government continues its comprehensive approach in supporting the rural and dairy sectors.

Milk output up 4% to 230.58 million tonnes in 2022-23: Govt

India's milk production rose by 4 per cent to 230.58 million tonnes in 2022-23 while egg output increased by 7 per cent to 138.38 billion, the government said on Sunday. Meat production rose by 5 per cent to 9.77 million tonnes during 2022-23 over the previous year.



Union Fisheries, Animal Husbandry & Dairying Minister Parshottam Rupala released the Basic Animal Husbandry Statistics 2023 (milk, egg, meat and wool production 2022-23) at the National Milk Day event in Guwahati. Rupala informed that the total milk production in the country is estimated at 230.58 million tonnes during 2022-23, registering a growth of of 3.83 per cent over the estimates of 2021-22.

In past, the annual growth rates were 6.47 per cent in 2018-19; 5.69 per cent in 2019-20; 5.81 per cent in 2020-21 and 5.77 per cent in 2021-22. Rupala stated that the highest milk-producing state during 2022-23 was Uttar Pradesh with a share of 15.72 per cent of total milk production followed by Rajasthan (14.44 per cent), Madhya Pradesh (8.73 per cent), Gujarat (7.49 per cent), and Andhra Pradesh (6.70 per cent). In terms of annual growth rate, Karnataka clocked the highest rate at 8.76 per cent followed by West Bengal (8.65 per cent) and Uttar Pradesh (6.99 per cent) over the previous year. Egg production has been estimated at 138.38 billion in 2022-23, up 33.31 per cent from 103.80 billion numbers in 2018-19. Egg output increased annually by 6.77 per cent in 2022-23 over 2021-22
